<b>Shopping Centres and Public Transport</b>	<ul style="list-style-type: none"> <li>Must take reasonable steps to maintain 1.5m physical distancing, and remember to wash hands often, wipe surfaces and cover coughs/sneezes.</li> <li>Note supermarkets, areas where food is served, hardware stores and distribution centres require a COVID Marshal.</li> </ul>		
<b>Shisha/Hookah</b>		Not Permitted

Notes: If any of the above events have 1000 people or more in attendance they will require a COVID Management Plan. The 1 person per 2 square metres rule does not include staff and must be calculated based on the area in which members of the public access. Gatherings at a private place are now restricted to no more than 100 people.
